

**RIDER AND SPECTATOR RELEASE OF LIABILITY**

Before being permitted to participate in any motorcycle trial event as a rider or spectator the following **Release of Liability** must be signed. If the rider or spectator is a minor under the age of eighteen (18) years, this Release must be signed on behalf of the minor by his or her parent or legal guardian.

**RELEASE OF LIABILITY**

In consideration of being permitted to participate in any motorcycle trial event or to be a spectator at any motorcycle trial event sponsored by Mid-America Trials Team, Inc., the undersigned agrees to and hereby **RELEASES** Mid-America Trials Team, Inc. and Grundy Social Club, Inc. together with all of their members, shareholders, employees, agents and event coordinators from any and all liability whatsoever for any personal injury or property damage which the undersigned may suffer in the course of participating in, observing or being a spectator the event. The undersigned expressly agrees to **RELEASE** Mid-America Trials Team, Inc. and Grundy Social Club, Inc. from their own future **negligence** or **fault**.

The undersigned is aware that he or she may be injured in the course of a motorcycle trial event and that injuries may result from, but are not limited to, collisions, flying debris, track conditions, equipment failures, safety equipment failures and motor vehicles leaving the intended course of operation. These risks may result in personal injury or property damage to participants and spectators and could even result in **death**. The undersigned agrees to hold harmless Mid-America Trials Team, Inc. and Grundy Social Club, Inc. from any liability, loss, cost, injury or damages, now sustained or sustained in the future caused by any alleged **negligence** or **fault** of Mid-America Trials Team, Inc. or Grundy Social Club, Inc. for any personal injury or property damage including, but not limited to, serious injury or death.

The undersigned agrees to personally assume full responsibility for any and all risks of injury or property damage by reason of participation in or attendance at a motorcycle trial held or sponsored by Mid-America Trials Team, Inc. understanding that riding in such events or observing such events as a spectator may at any time become dangerous.

This **Release of Liability** is executed by the undersigned with full understanding of its terms and with a full and knowing understanding of the risks assumed.

This **Release of Liability** shall be effective for any event in which the undersigned participates as a rider or spectator which is sponsored by Mid-America Trials Team, Inc. where the undersigned participates as a rider or spectator now or at any time in the future unless Mid-America Trials Team, Inc. and Grundy Social Club, Inc. agree in writing that the terms hereof shall not be effective for any such event.

By signing below all riders and spectators agree to be courteous and refrain from any intentional damage, harm, horseplay or unsafe riding or spectator practices of any kind.
